## CONDITIONS OF USE FOR THE SPORTS FACILITY AT AN INDIVIDUAL LEVEL

Dear user,

By entering the Sports Facility and/or signing this document, you consent to the following conditions of use:

- "Sports Facility" is understood to refer to the sports hall, changing rooms, showers, fitness rooms and storage area that are located on floor -1 of the Center Court, as well as all the sports equipment, facilities and materials located in those areas. "Owner" is understood to refer to Chemelot Campus Vastgoed C.V., "also trading under the name Brightlands Chemelot Campus. "Operator" is understood to refer to Bastiaens Vitality B.V.
- 2. You are only entitled to enter and use the Sports Facility after having signed these Conditions of Use (on a one-off basis). If the Sports Facility is closed, you must obtain a key from the reception. You must handle the key with care and are responsible for the consequences of losing the key. After use, the key must be returned to reception.
- 3. The opening times of the Sports Facility are: working days from 7 am to 7 pm. By way of derogation from the abovementioned opening times, the Owner reserves the right to close the Sports Facility if company sporting events are taking place or maintenance is being carried out.
- 4. You should leave the Sports Facility in the same condition in which you found it.
- 5. We expect all users to conform with the generally applicable standards of decency with respect to one another and the employees of the Owner and/or Operator. This means that you should treat one another with respect and refrain from causing noise and other nuisance. You should store used equipment in the place intended for it following use. The use of mobile phones in the sports hall and fitness rooms is not permitted. Entering the Sports Facility in outdoor shoes is prohibited.
- 6. You must ensure that the indicated escape routes in the Sports Facility are kept free of obstacles.
- 7. You are personally responsible for the correct use of sports equipment, facilities and materials.
- 8. Having regard to a (threatened) disaster or (threatened) irregularities, the Owner and/or Operator has the right to have any persons or objects located in the Sports Facility removed or to refuse their access to the Sports Facility (or have their access to the Sports Facility refused). The Owner and/or Operator is not liable for any costs and damage that may arise for you as a result of this.
- 9. You are liable to the Owner for damage inflicted to the Sports Facility (including sports equipment, facilities and materials) by you, unless the damage cannot be reasonably attributed to you. The Owner and/or Operator must be notified of the damage immediately.
- 10. The Owner and/or Operator is not liable for the loss, theft, disappearance of, or damage to, items that belong to you, or for personal injury caused to you.
- 11. The use of the changing rooms and showers is permitted in the 15 minutes before the start of the use time and for up to 15 minutes after the end of the use time.
